These terms and conditions of use (herein after these "**Terms**") are entered into between you (hereinafter referred to as "**you**", "**your**" or the "**User**") and Unergy (as defined below). By accessing, downloading, using or clicking on accept after filling in the checkbox to approve and/or use any Unergy's Services (as defined below), you agree that you have read, understood and accepted all of the terms and conditions stipulated in these Terms as well as our <u>Unergy's Privacy Policy</u>. In addition, when using some features of the Services, you may be subject to specific additional terms and conditions applicable to those features.

Please read these Terms carefully as they govern your use of the Services. THESE TERMS CONTAIN IMPORTANT PROVISIONS INCLUDING AN ARBITRATION PROVISION THAT REQUIRES ALL CLAIMS TO BE RESOLVED BY WAY OF LEGALLY BINDING ARBITRATION. The terms of the arbitration provision are set forth in Section VI, "Dispute Resolution", hereunder. As with any asset, the values of Unergy's Crypto Tokens (as defined below) may fluctuate significantly and there is a substantial risk of economic losses when purchasing, selling, holding or investing in Unergy's Crypto Tokens and their derivatives. BY MAKING USE OF UNERGY'S SERVICES, YOU ACKNOWLEDGE AND AGREE THAT: I) YOU ARE AWARE OF THE RISKS ASSOCIATED WITH TRANSACTIONS OF CRYPTO TOKENS AND THEIR DERIVATIVES; II) YOU SHALL ASSUME ALL RISKS RELATED TO THE USE OF UNERGY'S SERVICES AND TRANSACTIONS OF CRYPTO TOKENS AND THEIR DERIVATIVES; AND III) UNERGY SHALL NOT BE LIABLE FOR ANY SUCH RISKS OR ADVERSE OUTCOMES.

### **I.DEFINITIONS**

In these Terms and all documents incorporated herein by reference, the following words will have the following meanings unless otherwise indicated:

**A.** "**Unergy**" or "**Unergy**'s **Platform**" refers to an ecosystem comprising Unergy's websites (whose domain names include but are not limited to <u>https://www.unergy.io</u>), mobile applications, applets and any other applications that are developed to offer Unergy's Services. In case of any inconsistency between relevant terms of use of the above platforms and the contents of these Terms, the respective applicable terms of such platforms shall prevail.

B. "Unergy's Corporate Entity" refers to UNERGY S.A.S. a company duly incorporated under the laws of Colombia, with TAX ID No. 901.372.693 - 8, as the responsible for running Unergy; for convenience, unless otherwise stated, references to "Unergy", "Unergy's Platform" and "we" in these Terms specifically mean UNERGY S.A.S. UNDER THESE TERMS, UNERGY S.A.S. MAY CHANGE TO AN OTHER CORPORATE ENTITY UNDER ANOTHER JURISDICTION, AS UNERGYS'S BUSINESS ADJUSTS; IN WHICH CASE, THE CHANGED CORPORATE ENTITY SHALL PERFORM THEIR OBLIGATIONS UNDER THESE TERMS WITH YOU AND PROVIDE SERVICES TO YOU, AND SUCH CHANGE DOES NOT AFFECT YOUR RIGHTS AND INTERESTS UNDER THESE TERMS. ADDITIONALLY, THE SCOPE OF UNERGY'S CORPORATE ENTITY MAY BE EXPANDED DUE TO THE PROVISION OF NEW UNERGY'S SERVICES, IN WHICH CASE, IF YOU CONTINUE TO USE UNERGY'S SERVICES, IT IS DEEMED THAT YOU HAVE

IN CASE OF A DISPUTE, YOU SHALL DETERMINE THE ENTITIES BY WHICH THESE TERMS ARE PERFORMED WITH YOU AND THE COUNTERPARTIES OF THE DISPUTE, DEPENDING ON THE SPECIFIC SERVICES YOU USE AND THE PARTICULAR ACTIONS THAT AFFECT YOUR RIGHTS OR INTERESTS.

- **C.** "**Unergy's Services**" refers to various services provided to you by Unergy that are based on Internet and/or blockchain technologies and offered via Unergy's websites, mobile applications, clients and other forms (including new ones enabled by future technological development). Unergy's Service include but are not limited to Crypto Tokens trading exchange Platforms, Crypto-to-crypto Trading, Fiat Trading and novel services to be provided by Unergy.
- **D.** "Unergy's Platform Rules" refer to all rules, interpretations, announcements, statements, letters of consent and other contents that have been and will be subsequently released by Unergy, including these Terms, as well as all regulations, implementation rules, product process descriptions, and announcements published in Unergy's Platform or within products or service processes.
- **E.** "Unergy's Privacy Policy" means <u>Unergy's Privacy Policy</u> which are an integral part of these Terms and that can be reviewed.
- **F.** "Last Revised Date" means the date of the last version of these Terms as Unergy reserves the right to alter, revise, modify, and/or change these Terms at any time.
- **G.** "Users", "you" or "your" refer to all individuals, institutions or organizations that access, download or use Unergy or Unergy's Services and who meet the criteria and conditions stipulated by Unergy. If there exist other agreements for such entities as developers, distributors, market makers, and Crypto Tokens exchanges, such agreements shall be followed.

- **H.** "**Crypto Tokens**" refer to encrypted or digital tokens or cryptocurrencies with a certain value that are based on blockchain and cryptography technologies and are issued and managed in a decentralized form.
- I. "Unergy's Crypto Tokens" refer to Crypto Tokens that have been issued by Unergy.
- **J.** "**Crypto Tokens Wallet**" means a software application (or other mechanism) that provides a means for holding, storing, and transferring Crypto Tokens, including a User's Crypto Tokens Address, Crypto Tokens balance, and cryptographic keys.
- **K.** "**Crypto Tokens Address**" means an alphanumeric identifier that represents a potential destination for a Crypto Tokens transfer, which typically is associated with a User's Crypto Tokens Wallet.
- **L. "Unergy's Depositary Wallet**" means a non-Crypto Tokens Wallet through Unergy's Platform, where Unergy will be the custodian of the User's Crypto Tokens.
- **M.** "**Fiat**" means the money or currency of any country or jurisdiction that is: i) designated as legal tender; and ii) circulated, customarily used, and accepted as a medium of exchange in the country or jurisdiction of issuance.
- **N.** "**Reserves**" means traditional currency (or Fiat) and cash equivalents held by Unergy to support some of Unergy's Crypto Token.

- **O.** "Unergy's Accounts" refer to the foundational virtual accounts, including main accounts and subaccounts, which are opened by Unergy for Users to record on Unergy their usage of Unergy's Services, transactions, asset changes and basic information. Unergy's Accounts serve as the basis for Users to enjoy and exercise their rights on Unergy.
- **P.** "Crypto Tokens Convert Service" refers to the conversion that Users may use to acquire Unergy's Crypto Tokens in exchange of other Crypto Tokens, directly with Unergy
- **Q.** "Crypto-to-crypto Trading" refers to spot transactions in which one Crypto Token is exchanged for another Crypto Token (whether or not they are Unergy's Crypto Tokens).
- **R.** "Fiat Trading" refers to spot transactions in which Crypto Tokens are exchanged for Fiat currencies or vice versa.
- **S.** "**KYC**" refers to the "know-your-customer" process that Unergy has put in place before entering into a business relationship or conducting transactions with its Users. As part of this process, Unergy may do anything that it deems necessary in order to identify Users, verify their identity, scrutinize and investigate User transactions, or comply with any applicable Law or regulation.
- **T.** "**AML**" means anti-money laundering, including all Laws applicable to the Users or Unergy prohibiting money laundering or any acts or attempted acts to conceal or disguise the identity or origin of; change the form of; or move, transfer, or transport, illicit proceeds, property, funds, Fiat, or Crypto Tokens, including but not limited to the promotion of any unlawful activity such as fraud, tax evasion, embezzlement, insider trading, financial crime, bribery, cyber theft or hack, narcotics trafficking, weapons proliferation, terrorism, or economic sanctions violations, which may also require internal controls to detect, prevent, report, and maintain records of suspected money laundering or terrorist financing.

- **U.** "**Anti-Corruption**" means all Laws applicable to the Users or Unergy, prohibiting corruption or bribery of government officials, kickbacks, inducements, and other related forms of commercial corruption or bribery.
- V. "Counter-Terrorist Financing" means all Laws applicable to the Users or Unergy, in combating the financing of terrorism.
- **W. "Laws**" means all laws, statutes, orders, regulations, rules, treaties, and/or official obligations or requirements enacted, promulgated, issued, ratified, enforced, or administered by any government that apply to you or Unergy.
- X. "Sanctions List" means the "Specially Designated Nationals and Blocked Persons" ("SDN") List and the Non-SDN List, including the "Sectoral Sanctions Identifications List", published by the Office of Foreign Assets Control ("OFAC") of the United States of America (the "US"); the Section 311 Special Measures for Jurisdictions, Financial Institutions, or International Transactions of Primary Money Laundering Concern published by FinCEN; and, any other foreign terrorist organization or other sanctioned, restricted, or debarred party list published by the FIA, or under Economic Sanctions, AML, or CTF Laws of or by Governments of the US, the British Virgin Islands, the United Nations, or any other jurisdiction or Government, as applicable to you or to the Site, as amended, supplemented, or substituted from time to time.
- **Y. "Restricted Location**" means any country or locations designated by Unergy where Unergy Services will not be provided on a full or limited basis.

### II. GENERAL PROVISIONS

Therefore, Unergy's Privacy Policy and all other agreements entered into separately between you and Unergy are deemed supplementary terms that are an integral part of these Terms and shall have the same legal effect. Your use of Unergy's Services is deemed your acceptance of the above supplementary terms.

3. <u>Changes of these Terms:</u> Unergy reserves the right to change or modify these Terms in its discretion at any time. Unergy will notify such changes by updating these Terms on its website (unergy.io) and modifying the Last Revised Date displayed on this page. All modifications or changes to these Terms will become effective upon publication on the website or release to the Users. Therefore, your continued use of Unergy's Services and Unergy's Platform is deemed as your acceptance of the modified agreement and rules of these Terms. If Unergy is informed that any Crypto Tokens or funds held in your Unergy's Account are stolen or otherwise are not lawfully possessed by you, Unergy may, but has no obligation to, place an administrative hold on the affected Crypto Tokens or funds and your Unergy's Account. If Unergy does

lay down an administrative hold on some or all of your Crypto Tokens or funds or your Unergy's Account, Unergy may continue such hold until such time as the dispute has been resolved and evidence of the resolution acceptable to Unergy has been provided to Unergy in a form acceptable to Unergy. Unergy will not involve itself in any such dispute or the resolution of the dispute. You agree that Unergy will have no liability or responsibility for any such hold, or for your inability to withdraw Crypto Tokens or funds or execute trades during the period of any such hold.

### C. Remaining Funds After Unergy's Account Termination

1. <u>General Provision:</u> Except as set forth in the nexts paragraph below, once an Unergy's Account is closed/withdrawn, all remaining account balance (which includes charges and liabilities owed to Unergy) will be payable immediately to Unergy. Upon payment of all outstanding charges to Unergy (if any), Users will have five (5) business days to withdraw all Crypto Tokens or funds from canceled Unergy's Account.

2. <u>Remaining Funds After Unergy's Account Termination Due to Fraud, Violation of Law, or</u> <u>Violation of These Terms:</u> Unergy will maintain full custody of the Crypto Tokens, funds and User data/information which may be turned over to governmental authorities in the event of an Unergy's Accounts' suspension/closure arising from fraud investigations, investigations of violation of Law or violation of these Terms.

### **D.** Inactive accounts

Notwithstanding any provision of this, Unergy may provide a written notice requiring you to close all of your open positions and withdraw all of your Crypto Tokens from your Unergy's Account within thirty (30) days of the notice. ### A. Notice of Claim and Dispute Resolution Period

PLEASE CONTACT UNERGY FIRST! Unergy wants to address your concerns without resorting to formal legal proceedings, if possible. If you have a dispute with Unergy, then you should contact Unergy and a ticket process number will be assigned to you. Unergy will attempt to resolve your dispute internally as soon as possible. You agree to negotiate with Unergy in good faith to resolve the dispute (which discussions shall remain confidential and be subject to applicable rules protecting settlement discussions from use as evidence in any legal proceeding).

In the event the dispute cannot be resolved satisfactorily, and you wish to assert a legal claim against Unergy, then you agree to set forth the basis of such claim in writing in a "Notice of Claim," as a form of prior notice to Unergy. The Notice of Claim must; i) describe the nature and basis of the claim or dispute; ii) set forth the specific relief sought; iii) provide the original ticket process number; and iv) include your Unergy's Account email. The Notice of Claim should be submitted to an email address or hyperlink provided by Unergy in Unergy's Platform. After you have provided the Notice of Claim to Unergy, the dispute referenced in the Notice of Claim may be submitted by either Unergy or you to arbitration in accordance with the next paragraph of these Terms, below. For the avoidance of Claim to Unergy are prerequisites to commencement of an arbitration proceeding (or any other legal proceeding). During the arbitration, the amount of any settlement offer made by you or Unergy shall not be disclosed to the arbitrator.

### B. Agreement to Arbitrate and Governing Law

You and Unergy's Corporate Entity agree that any dispute, claim, or controversy between you and Unergy (and/or Unergy's Corporate Entity) arising in connection with or relating in any way to these Terms or to your relationship with Unergy (and/or Unergy's Corporate Entity) as a user of Unergy's Services (whether based in contract, tort, statute, fraud, misrepresentation, or any other legal theory, and whether the claims arise during or after the termination of these Terms) will be determined by mandatory final and binding individual (not class) arbitration. You and Unergy (and/or Unergy's Corporate Entity) further agree that the arbitrator shall have the exclusive power to rule, including without limitation any objections with respect to the existence, scope or validity of the Agreement to Arbitrate, or to the arbitrability of any claim or counterclaim. The arbitration provisions set forth in this Section will survive termination of these Terms.

The arbitration shall be subject to the Arbitration and Conciliation Center of the Bogotá Chamber of Commerce (*Centro de Arbitraje y Conciliación de la Cámara de Comercio de Bogotá*), in accordance with its rules (the "Rules"). The arbitration will be administered by the Arbitration and Conciliation Center of the Bogotá Chamber of Commerce. Regardless of the manner in which the arbitration is conducted, the arbitrator shall issue a reasoned written decision sufficient to explain the essential findings and conclusions on which the decision and award, if any, are based. Governing Law: These Terms (including this arbitration agreement) shall be governed by, and construed in accordance with, the Laws of Republic of Colombia. Seat of Arbitration: The seat of the arbitration shall be Bogotá, Colombia. Place of Hearing: The location of any in-person arbitration hearing shall be Bogotá, Colombia, unless otherwise agreed to by the parties. Language: the language of the arbitration should be english, unless otherwise agreed to by the parties.

If we request arbitration against you, we will give you notice at the email address or mailing address you have provided. You agree that any notice sent to this email or mailing address shall be deemed effective for all purposes, including without limitation to determinations of adequacy of service. It is your obligation to ensure that the email address and/or mailing address on file with Unergy is up-to-date and accurate.

### C. Class Action Waiver

You and Unergy agree that any claims relating to these Terms or to your relationship with Unergy as a User of Unergy's Services and Unergy's Platform shall be brought against the other party in an arbitration on an individual basis only and not as a plaintiff or class member in a purported class or representative action. You and Unergy further agree to waive any right for such claims to be brought,

Subject to the applicable Law, your continued use of your Unergy's Account, Unergy's Services or Unergy's Platfomr shall be deemed to be your acceptance of any modifications to these Terms regarding the Agreement to Arbitrate. You agree that if you object to the modifications to this Section, Unergy may block access to your Unergy's Account pending closure of your account. In such circumstances, the Terms of Use prior to modification shall remain in full force and effect pending closure of your Unergy's Account.
